CORRECTION TO BID FORM:

The estimated weekly pickup at Glendale Home is changed to 1000 gallons/week.

QUESTIONS SUBMITTED:

- 1.) Are vendors required to bid on both sites for consideration of an award?
RESPONSE: No, the County has reserved the right to award these sites separately or together. Bidding on a single site is acceptable.**
