Notice is hereby given that Schenectady County will accept sealed bids for: **River Road / Rosendale Road Intersection Improvement Project**. Project consists of a one-lane roundabout at the intersection of River Road and Rosendale Road in the Town of Niskayuna, Schenectady County. Specifically this project includes asphalt pavement rehabilitation and reconstruction, installation of granite curb, closed drainage, roadway lighting, signage, striping, and landscaping.

Contract will be awarded based upon the lowest qualified bid. Bids received after the above noted time will not be accepted. All sealed envelopes should be clearly labeled "BID FOR RIVER ROAD / ROSENDALE ROAD INTERSECTION IMPROVEMENT PROJECT, RFB-2019-49". The sealed bids shall include the completed Bid Form, Non-Collusive Bidding Certification (as required by chapter 956 of the Laws of New York State), and Bid Bond.
